Proceedings:

Dr. Nazeer Shaik, Principal and the Member Secretary welcomed all the members to the hybrid mode meeting of the 16th Governing Body (Autonomous). The members discussed and resolved the following in accordance with the agenda.

Minutes of the meeting:

- Confirmation of the Minutes of 15th Governing Body (Autonomous) meeting The minutes of the meeting of 15th Governing Body (Autonomous) were confirmed.
- To appraise the members about the progress, achievements of the college.
 Dr. Nazeer Shaik, Principal & Member Secretary Governing Body (Autonomous) briefed the members about the progress of the college and achievements of the college since 15th Governing Body(Autonomous) meeting to till date. The salient points are as follows.
 - The Principal informed the members about enhancement of the seats in Data Science from 60 to 120, reduced the seats in Civil and Mechanical Engineering from 90 to 60 and closure of Electronics & Instrumentation branch from this academic year (2023-24).
 - The placement statistics for the academic year 2022-23 and 2023-24 till date were presented.
 - The statistics of the exam results of second semester of 2022-23 academic year were presented.
 - The Principal briefed the members that, Institute accredited with A+ grade with 3.49 CGPA out of 4 point scale by National Assessment and Accreditation Council (NAAC), Times of India Engineering Institute Survey ranking-2023 ranked with 16th rank in the category of top private engineering Institutes in Andhra Pradesh and 6th rank in the category of Infrastructure, Research Capabilities and placement, Institute certified with ISO-OSI certification and briefed about progress of the NBA Accreditation process.
 - All the members were congratulated and appreciated about the progress of the accreditations of the Institute.
- 3. Approval of Service Rules of Bapatla Engineering College (Autonomous)
 Prof. Onkar Singh, UGC nominee suggested to constitute three men
 committee with the composition of i) State Govt. nominee, ii) University
 nominee and iii) Principal to examine and place their suggestions if any to
 the Governing Body of the Society for approval. Subsequently, the same may
 be placed before this committee for ratification.
- Result Analysis of Graduated Students for the A.Y. 2022-23. 2022-23 Graduated Students Result Analysis Presented and results were approved by the members.

- 5. Ratification of staff recruited in the A.Y. 2022-23 & 2023-24. The Principal briefed the recruitment procedure and as per the AICTE norms recruited the faculty in various departments by the college in the A.Y. 2022-23 and 2023-24. All the members were ratified the appoints of all the faculty in the A.Y. 2022-23 & 2023-24.
- The Principal presented the minutes of the Governing Body meeting of the society held on 26/08/2023(Sat) where it was resolved to recommend the Governing Body(Autonomous) of Bapatla Engineering College to appoint the present in-charge Principal Dr. Nazeer Shaik as regular Principal for a period of 2 years from the date of his appointment.

- 6. Approval of the budget for the F.Y 2023-24. The Principal presented the Finance Committee recommended budget for the F.Y 2023-24 and all the members were approved. Prof. V Subbarao, JNTUK suggested to allocate the more budget to R&D activities and seed money to the faculty members to encourage R&D activities in the Institution.
- 7. Any other subject with the permission of the chair. The Principal requested suggestions from members on the new UGC guidelines regarding the constitution of Governing Body (Autonomous). Prof. Onkar Singh suggested to take legal opinion on constitution of new Governing Body (Autonomous) as per the new UGC guidelines since time period of existing members is not yet completed. However, the proposed new Governing Body (Autonomous) as per the new UGC guidelines may be placed for approval in the next Governing Body (Autonomous) meeting.
