**Report on the Audit of the Financial Statements
Opinion**

Those charged with governance are responsible for overseeing the entity's financial reporting process.

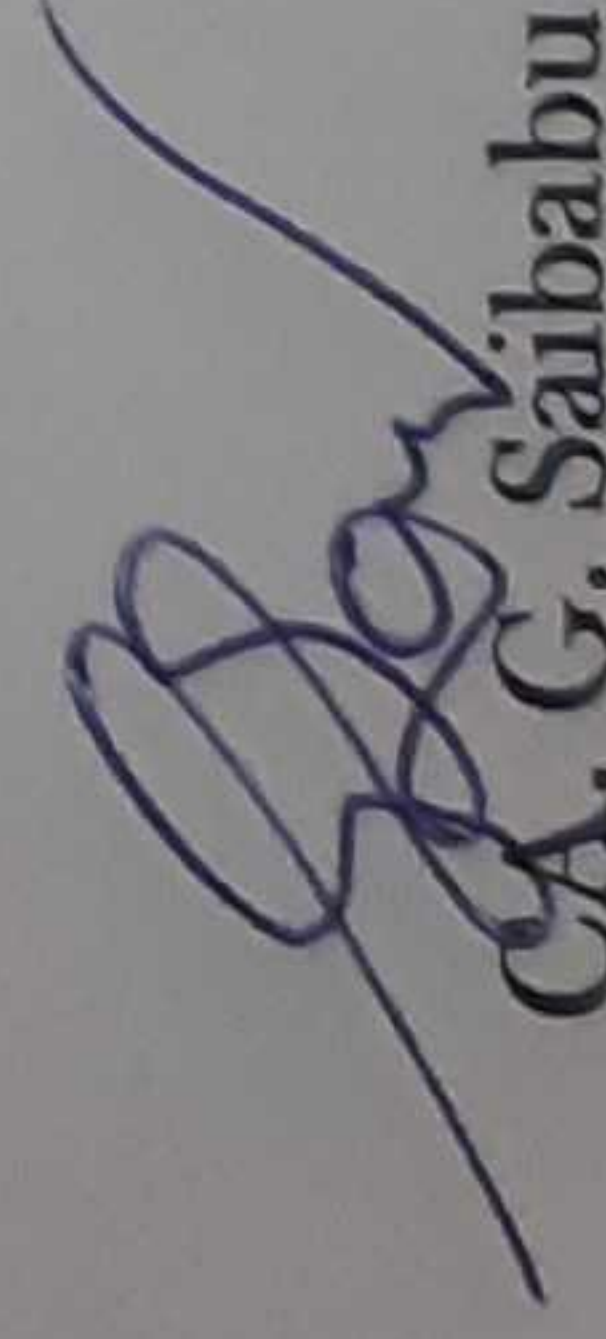
Auditor's Responsibilities for the Audit of the Financial Statements

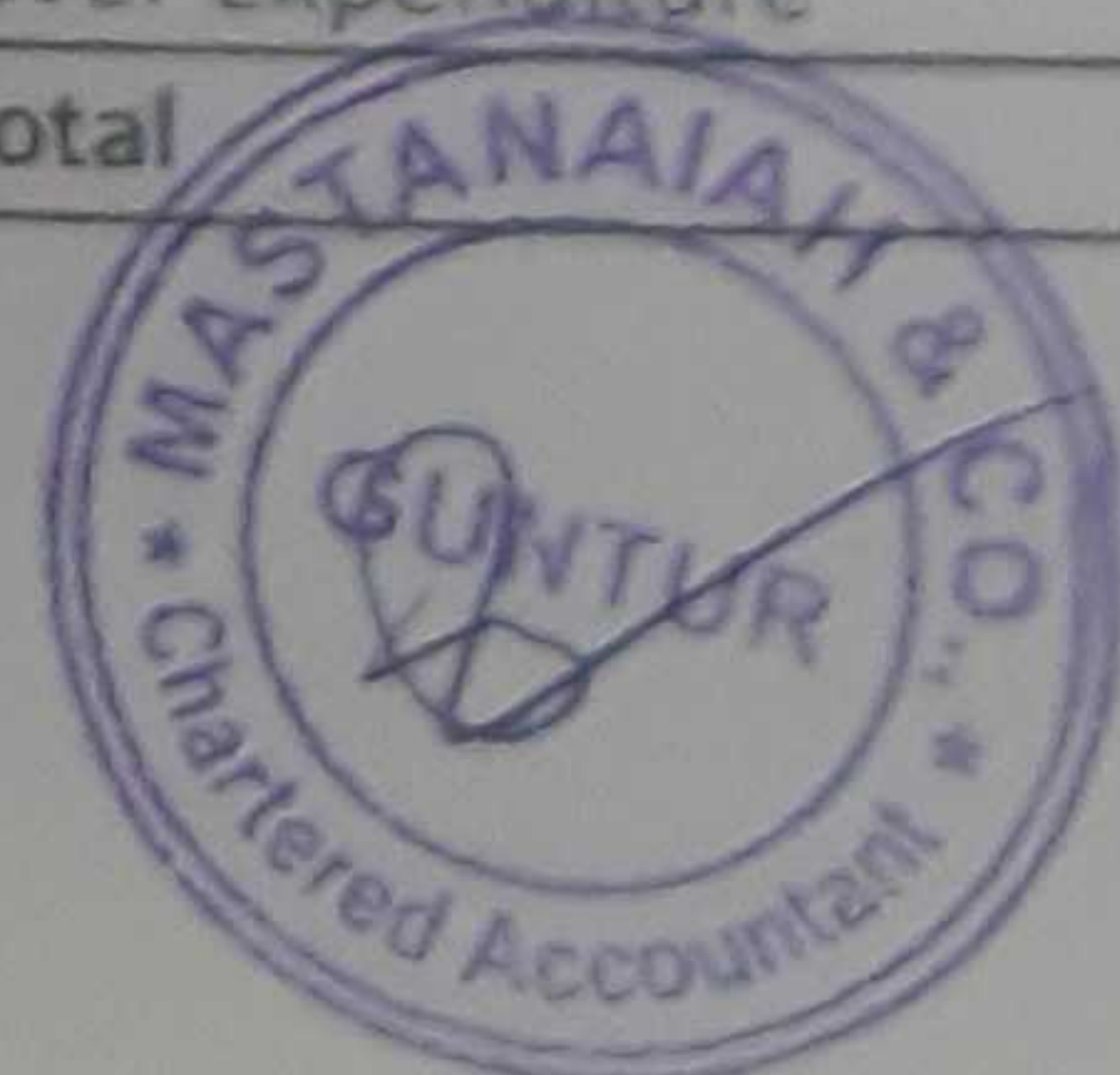

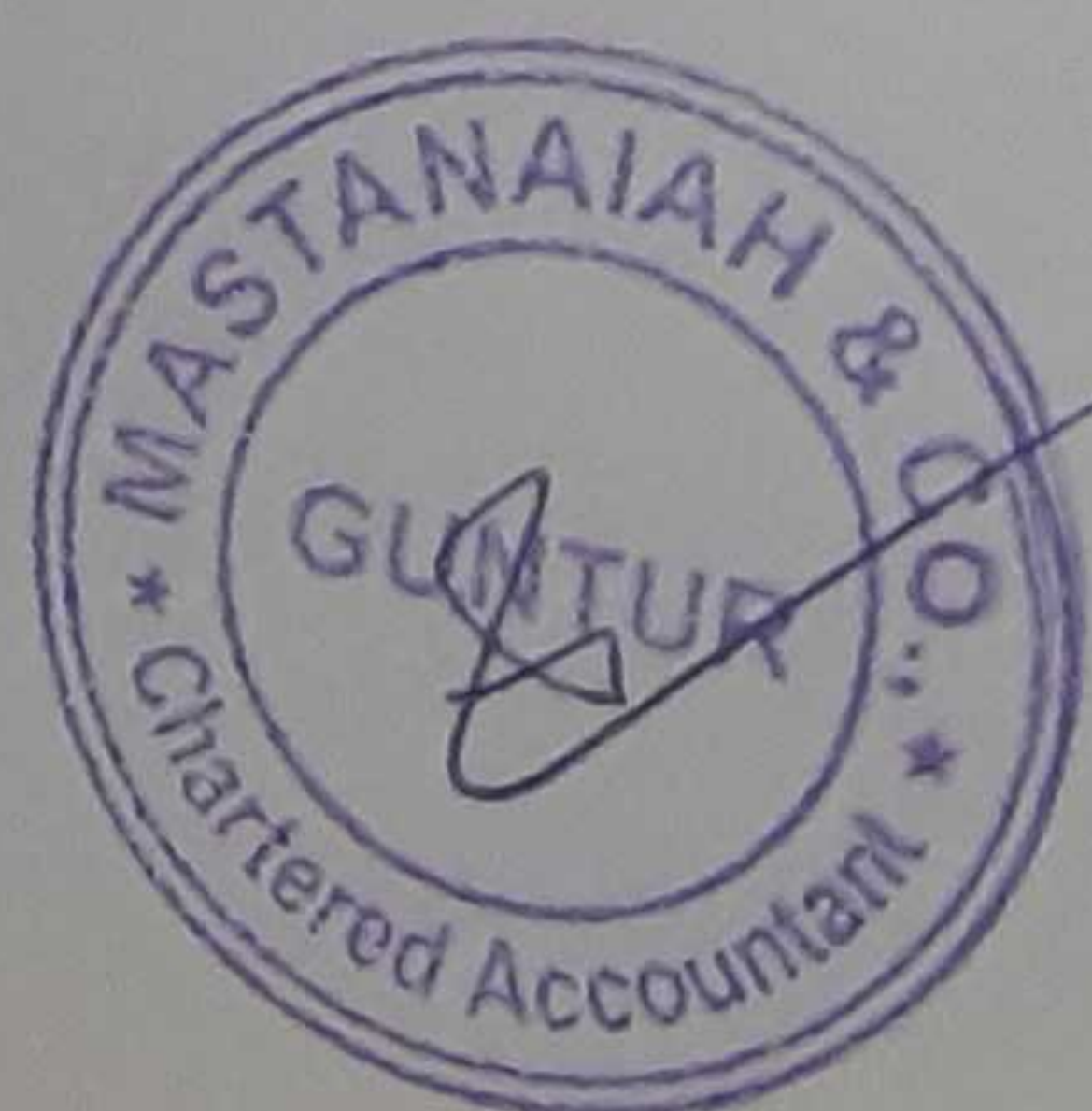
