Resolutions:

- It is resolved to rusticate I. Purandhar, Y21AEC446 for the coming two academic years with immediate effect.
- After completion of two years, he needs to submit a medical certificate from any government medical college psychology professor/head of the department, that he has undergone proper medical treatment, he is mentally stable and fit to continue his studies in a campus environment.
- Only after satisfactory fulfillment of the above conditions, the principal shall have the discretion to readmit him in to the college after the rustication period.
