- **Mode of Payment for Y21 / L22 (Current IV-year students)** : The Examination fee should be paid through HDFC Bank payment gateway, either by downloading the App from play store or by scanning the QR code. The details are attached to this notice.
- **Mode of Payment for Y20 / L21 Batch Students (Passed out students):** The applicants must pay the fee by depositing the same in the Bank Account No. 36308770022 through the Swiping machines arranged at COE office.
- After payment the student must submit the payment receipt in the COE office. *Supplementary candidates must apply indicating the subjects for which they are appearing along with the fee receipt and copy of downloaded result copy in the COE office.* If students pay the exam fee by any other method, a refund will not be given. They must pay the exam fee again.
- The students who fail to pay the examination fee and submit the fee receipt within the prescribed date (after 03.12.2024) must take permission from the Controller of Examinations and must pay the exam fee with a fine of Rs. 500/-
